EXTENDING THE TERM OF THE ORIGINAL LEASE AGREEMENT WITH
PENNSYLVANIA STATE REPRESENTATIVE WILL TALLMAN**

WHEREAS, the Board of Supervisors of North Newton Township, on December 22, 2014, entered into a lease agreement with Representative Will Tallman for office space to be used as a satellite office on the second and fourth Thursday of each month and;

WHEREAS, the original agreement of December 22, 2014 stated a term commencing on January 1, 2015 and ending March 30, 2015, unless extended on a month to month basis via mutual written agreement and;

WHEREAS, the Board of Supervisors believes the use of the satellite office has been beneficial to the community and;

WHEREAS, the Board of Supervisors desires to extend the lease agreement for the remainder of the year 2015 without further monthly action of the Board;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of North Newton Township to hereby approve an extension of the lease agreement from this date until the end of December 2015 unless revoked in writing providing no less than thirty (30) days notice.


