

**RESOLUTION NO. 2016-12  
NORTH NEWTON TOWNSHIP**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF  
NORTH NEWTON TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA,  
ESTABLISHING FEES FOR GARBAGE, RECYCLABLES AND  
BULK ITEM COLLECTION**

**WHEREAS**, Section 1506 of the Act of May 1, 1993 (P.L. 103, No. 69), known as The Second Class Township Code, reenacted and amended November 9, 1994 (P.L. 350, No. 60), authorizes the Township to adopt any Ordinance, rule, or regulation necessary for the care and control of the township and its finances; and

**WHEREAS**, this Board adopted Ordinance No. 2011-5, dated November 14, 2011 relating to collection, storage and disposal of garbage; and

**WHEREAS**, Article IV of Ordinance No. 2011-5 authorizes the Township to, by Resolution, establish a fee schedule for each service option.

**NOW, THEREFORE, BE IT RESOLVED, AND IT HEREBY IS RESOLVED**, by the Board of Supervisors of North Newton Township, Cumberland County, Pennsylvania, as follows:

1. The preamble recited above is incorporated by reference herein.
2. The following fees are hereby imposed for the collection of garbage, recyclables, and bulk items:

A. Full Service	\$47.00 per quarter
B. Full Service (Senior Citizens)	\$42.50 per quarter
C. Per Bag	\$ 3.50
3. The fees set forth above may be reviewed and changed from time to time by Resolution of the Board of Supervisors.
4. All other Ordinances and Resolutions, or portions thereof, that are inconsistent herewith, are hereby repealed.
5. The rates set forth above shall be effective as of July 1, 2016 and shall continue in full force and effect until amended or repealed by the Township.
