**A RESOLUTION OF THE BOARD OF SUPERVISORS OF NORTH NEWTON TOWNSHIP,
AUTHORIZING A REVISION TO THE EMERGENCY OPERATIONS PLAN FOR
NORTH NEWTON TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA**

WHEREAS, Section 7503 of the Pennsylvania Emergency Services Code, 35 Pa. C.S. Section 7101 et seq. mandates that North Newton Township prepare, maintain and keep current an emergency operations plan for the prevention and minimization of injury and damage caused by a major emergency or disaster within this Township; and

WHEREAS, in response to the mandate stated above, this Township has prepared an emergency operations plan to provide prompt and effective emergency response procedures to be followed in the event of a major emergency or disaster; and

WHEREAS, this Township has also prepared an emergency operations plan in order to reduce the potential effects of a major emergency or disaster and to protect the health, safety and welfare of the residents of this Township;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of North Newton Township to approve, adopt and place into immediate effect the Emergency Operations Plan of North Newton Township. This Plan shall be reviewed every two years to make certain that it conforms to the requirements of the Cumberland County Emergency Guideline.
