**A RESOLUTION OF THE BOARD OF SUPERVISORS OF NORTH NEWTON TOWNSHIP,
CUMBERLAND COUNTY, PENNSYLVANIA,
ADOPTING A REVISED SCHEDULE OF FEES FOR 2018**

WHEREAS, the Board of Supervisors of North Newton Township is authorized and empowered to set reasonable and necessary fees to reimburse the Township for the costs and the expenses of processing, issuing, tracking, and reviewing applications for land use permits, subdivision and land development plan approvals, zoning permits, sewage facilities permits, stormwater management plans and approvals, road occupancy permits, park facility rentals and other administrative services; and

WHEREAS, the Board has considered and reviewed the actual costs associated with the foregoing;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of North Newton Township to adopt the attached fee schedule effective April 3, 2018.



- **Minor Subdivision Plan** \$350.00
Combines preliminary and final plan review processes into one submission. To qualify, a plan must contain no more than six (6) lots, including any residual parcel, must be for residential purposes and must not contain new streets or rights-of-way.

- **Preliminary Subdivision Plan**
Includes residential or non-residential plans.

	<i>7 thru 25 lots:</i>	\$10.00/lot
	<i>26 thru 50 lots:</i>	\$5.00/lot
	<i>51 lots and above:</i>	\$2.00/lot

- **Final Subdivision Plan**
Includes residential or non-residential plans.

	<i>51 lots and above:</i>	\$2.00/lot

- **Minor Land Development Plan** \$350.00
As with subdivision, this type plan combines the preliminary and final plan review into one submission. To qualify, a plan must have no more than 2 principal non-residential structures on 1 parcel of land 5 acres or less in size, or no more than 8 residential units – such as apartments or townhouses – on 1 parcel of land and contain no new streets or rights-of-way.

*** Subdivision & Land Development Plans**

If a plan contains both a subdivision of land and land development, the fees would be calculated by adding the separate subdivision and land development fees and multiplying the sum by 70%.

Special Agency Fees:

Applicant for subdivision or land development approval shall be responsible for payment of review fees to the Cumberland County Planning Commission, the Cumberland County Conservation District, the PA Department of Environmental Protection and other agencies as may be involved in the review process or with the issuance of special permits necessary to the review process.

RECREATION FEE FOR DEVELOPMENT PURPOSES

- Residential Subdivision or Land Development: \$500/dwelling unit
- Non-Residential Subdivision or Land Development w/no public water or sewer: Project land area @ \$500/acre
- Non-Residential Subdivision or Land Development w/public water or sewer: Project land area @ \$750/acre
- Non-Residential Subdivision or Land Development w/public water & sewer: Project land area @ \$1,450/acre

ENGINEER REVIEWS OR CONSULTATION

Applicants for subdivision and/or land development approvals shall reimburse North Newton Township one hundred percent (100%) of actual cost of engineering and professional consultation reasonably necessary to the review, processing, revision, inspection, testing and preparation or required security and improvement documentation. The amount of such fees shall be based on the actual rate or cost charged to North Newton Township by such consultant for services rendered.

STORMWATER MANAGEMENT PLAN SUBMITTAL

The Board of Supervisors has authorized the Township Engineer to conduct reviews of Stormwater Management Plans and inspect the installation of stormwater improvements on behalf of the Township. The Township does not require a plan submittal fee, but does require one hundred percent (100%) reimbursement of engineering costs incurred by the Township for the review and inspections associated with the plan.

RECORDING FEE

All plans to be recorded with the Cumberland County Recorder of Deeds' Office will be recorded by the Township. The recording and certification fee will be one hundred percent (100%) reimbursable to the Township.

PAYMENT OF FEES

The township will not accept the submittal of any plan without the appropriate filing fee. In addition, all professional consulting fees, recreation fee, recording fees and security must be reimbursed or received before the approved plan will be released to the applicant.
