§ 300-155 Conditional Uses - Procedure.

The procedure for requesting a Conditional Use in any zoning district shall be as follows:

- A. The applicant shall file an application for a Conditional Use Permit with the Board of Supervisors. The application shall contain the following information or material:
 - 1. Names and addresses of adjoining property owners, including properties directly across a public right-of-way.
 - 2. A scaled drawing (site plan) of the site with sufficient detail and accuracy to demonstrate compliance with all applicable provisions of Chapter 300 of the Code.
 - 3. A written description of the proposed use in sufficient detail to demonstrate compliance with all applicable provisions of Chapter 300 of the Code.

- B. The Board of Supervisors submits the Conditional Use Application to the Planning Commission at least 30 days prior to the date of the hearing. The Planning Commission reviews the application and makes recommendations to the Board of Supervisors.
- C. Following public notice as required by law, the Board of Supervisors conducts a public hearing, which may be part of the Board of Supervisors' regular monthly meeting.
- D. The applicant is provided, either in person or by mail, a written notice of the decision or findings of the Board of Supervisors not later than the business day following the issuance of such notice. The written notice must be issued within 45 days of the last hearing on the conditional use application.
- E. Conditional Uses which are granted are subject to time limitations as set forth in § 300-155.E of the Code.
